"EYES ON THE EVENT IN 5 SECONDS"



During February 2020, LEAPS was dispatched 284 times totaling 38.1 hours providing airborne tactical and strategic surveillance for 244.5 hours. LEAPS provided real-time visible and infrared (IR) imagery within the Lancaster and surrounding incorporated and unincorporated areas in the Antelope Valley Los Angeles County Sheriff's Department (LASD) area of responsibility.

This month, LEAPS assisted with recovering 4 stolen vehicles with 4 arrests. Vehicles were recovered from 20th Street East and Avenue J, 10th Street East and Avenue J and Avenue H-8 at Genoa.

Several transient fires were found at 20th Street East and Avenue H and at 15th Street West at Avenue J-8.

LEAPS assisted with other fires, including an RV fire at Avenue K and 20th West, and a fire in a back yard near 47th Street East and Avenue K-8.

LEAPS assisted with several DUI calls and tracked the suspect vehicle to their residence until deputies arrived to make contact with the suspected DUI driver. These calls occurred in the 100 block of East Avenue J-8 and in the 42000 block of 30th Street West.

LEAPS Provided assistance for several reports of road rage. In one case reported near 20th Street West and Avenue I, LEAPS tracked the suspect vehicle until deputies were on scene to stop the vehicle.

A large fight broke out at the Cinemark theatre located at Avenue I and Valley Central Way. LEAPS tracked one suspect that fled on foot from the scene.

LEAPS responded to another fight call in the 44000 block of Benald. 10 arrests were made.

LEAPS assisted locating theft/burglary suspects from local stores. In one case, LEAPS located and tracked the suspect from the Home Depot located at Avenue J and 20th Street West until deputies arrived, and took the suspect into custody. In another case, LEAPS used it's infrared imagery at night to locate two burglary suspects that fled Marshall's at Valley Central Way.
