(LEAPS)

PROVIDES AERIAL **TACTICAL** AND **STRATEGIC** RECONNAISSANCE FOR THE **CITY OF** LANCASTER AND THE LOS ANGELES COUNTY SHERIFF'S DEPARTMENT

During August 2020, LEAPS was dispatched 64 times totaling 8.5 hours of airborne tactical support. LEAPS provided a total of 24.5 hours of strategic surveillance. LEAPS provided real-time visible and infrared (IR) imagery within the Lancaster and surrounding incorporated and unincorporated areas in the Antelope Valley Los Angeles County Sheriff's Department (LASD) area of responsibility.

Highlights from this month, include the following:

LEAPS provided aerial support for the Los Angeles County Sheriff's Department Palmdale station, to monitor a gathering of 20 to 25 protesters at the Sheriff's station parking lot.

Dispatched to the area of 50th Street West and Avenue M, LEAPS observed a small group of Black Lives Matter protestors.

In the Antelope Acres area near 90th Street West and Avenue E. LEAPS was called to observe a report of domestic violence. Being first on the scene, LEAPS was able to identify the suspect who was wielding a shovel and threatening to assault the victim. LEAPS followed the suspect in the yard, until deputies arrived. The suspect was taken in to custody.

In responding to a report of two males fighting at a bus stop near 15th Street West and Avenue J. LEAPS arrived and monitored the two individuals until law enforcement arrived.

One suspect was arrested in the 44300 block of 33rd Street West, when LEAPS was able to provided surveillance of a stolen vehicle

Responding to two attempted suicide calls one being on West Hemlock Avenue and the other on East Langhorn Street.

LEAPS responded to a call of shots fired at a home in the 2000 block of West Avenue J-13. Deputies were unable to locate evidence of a shooting.

In the vicinity of the 4200 block of West Avenue J-13. LEAPS responded twice to a large party disturbance. The previous week Deputies had responded to a gun shot victim call at the same address.

Being dispatched to investigate a possible person with a gun in a bank parking lot near 30th Street West and Avenue L, both Deputies and LEAPS scoured the area but were unable to locate the person.

LEAPS responded to a hit and run with an injury call in the vicinity of 20th Street East and Avenue E.

Quick responses by LEAPS involved several emergency calls of fire including a reported brush fire in the vicinity of 10th Street East and Avenue H. Another was on a building roof in an apartment complex of the 500 block of West Ivesbrook Street.

LEAPS has implemented new technology allowing the system to provide imagery in almost any part of the Antelope Valley, including remote locations that could not be easily supported before without additional ground support equipment.
